Town Board Proceedings

February 18, 2026

Meeting of the Town Board of the Town of Chippewa was called to order on February 18, 2026 @ 5:34pm. Motion by J. Bruch, second by K. Pritzl to approve payment of Checks (165493-16620, C20260107-C20260203) in total of \$332,638.32. Motion carried.
